1. General Information

These Terms of Use govern your access to and use of the ICIMC 2026 website operated at <https://icimc2026.org>. The website is provided for the purpose of sharing information and providing services related to ICIMC 2026, including abstract submission, registration, program information, sponsorship and exhibition information, and conference communications.

These Terms, together with any additional notices or policies posted on the website, form the agreement between you and the ICIMC 2026 Organizing Committee regarding your use of the website.

2. Agreement to the Terms

By accessing or using the ICIMC 2026 website, creating an account, submitting an abstract, registering for the conference, or submitting an inquiry, you confirm that you have read, understood, and agree to be bound by these Terms.

If you do not agree to these Terms, you should not access or use the website.

3. Changes to the Terms

ICIMC 2026 may update, modify, add, or remove provisions of these Terms when necessary. Updated Terms will be posted on the website with the revised effective date.

Your continued use of the website after updated Terms are posted constitutes your acceptance of the revised Terms.

4. Provision and Use of the Website

The ICIMC 2026 website is provided to support conference-related information and services. You may use the website only for lawful purposes and in accordance with these Terms and any applicable notices, policies, and laws.
